On Thursday, April 29, 2021, at 10 a.m., the full Board meeting of the Board of Trustees will be held at Stone Center, Large Dining Room and President's Office, Southern Illinois University System Office, 1400 Douglas Drive, Carbondale, Illinois. For the open portion of the meeting, the items are listed on the attached agenda. Then it is expected that the regular session of the meeting of the Board of Trustees will recess for a Board executive session and Board committee meetings. The Chairman has called an executive session meeting via teleconference of the Board of Trustees. For the executive session meeting, it is expected that a motion will be made to close the meeting to the public for the purpose of considering pending, probable or imminent court proceedings against or on behalf of the Board; information regarding appointment, employment, compensation, discipline, performance or dismissal of employees or officers; and review of executive session minutes.

On Thursday, April 29, 2021, at 11:00 a.m., the Academic Matters Committee of the Board of Trustees will meet at the Stone Center, Large Dining Room, Southern Illinois University System Office, Carbondale, Illinois. The meetings of the Finance Committee and Architecture and Design Committee will immediately follow. At the conclusion of the Board committee meetings, the regular session of the full Board meeting of the Board of Trustees will resume. A news conference will be held immediately following the meeting.

To avoid health concerns related to the COVID-19 pandemic, and to comply with current guidelines, applicable law, and various orders, including those issued by the Governor of the State of Illinois, the open portions of the meetings can be viewed via live stream video link at siusystem.edu through Youtube and via Zoom videoconference.
