## Other FY 23 Outcomes

- Established Campus Liaison Teams
  - Members are identified as key personnel in carrying out the mission of OCE. The purpose of each campus team is to serve in an advisory capacity and aid in the coordination of campus resources as resources to address community identified needs are identified. Team membership is for a term of 1-year. Meetings are held bi-monthly. Each meeting features a system-level collaboration opportunity.

## FY 24 goals

- Finalize external advisory group.
- Use the Illinois State Appropriation (\$266,000) to build OCE staff.
  - Hire a shared project coordinator, grant writer and administrative assistant, with Institute for Rural Health.
- Establish OCE procedures for working with communities.
- Launch a communications and marketing plan that includes:
  - Internal (e.g., campus tours and print/digital materials) and
  - External communications (print/digital materials for community and for legislators; a much more robust website for OCE).
